About NUAA:

New South Wales' Drug User Organisation

The NSW Users and AIDS Association (NUAA) started in 1989 when a group of people who inject and their supporters came together in response to the HIV epidemic.

Today, with core funding from the NSW Government's Health Department and limited one off grants, NUAA provides a number of projects and services from across five areas:

- Promotion of the health and well being of people who use drugs
- Empowerment of people who use drugs
- Advocacy for healthy public policy
- Strengthening alliances and partnerships
- Building organisational capacity

NUAA's programs and services are delivered by the following program areas:

- Community Programs and Services Team who provide innovative and
 comprehensive health promotion, treatment and care activities and interventions that
 focus on networks or communities of people who inject drugs, using a community
 development approach. The team also provide NUAA's Needle and Syringe
 Programs, support and referral, health education and information to people who
 inject drugs, and information and advice for health workers, health agencies and
 other organisations responding to the needs of people who inject drugs.
- Policy, Advocacy and Communications Team who oversee NUAA's policy work and activities such as our policy documents, hosting policy symposiums and representing the organisation on various committee and advisory structures. In addition the team develops and disseminates NUAA's resources such as Users News our quarterly magazine, The NUAA Newsflash our regular newsletter and oversees our website
- Organisational Services who support NUAA's operations. This includes financial, human resources and asset management, risk management, member services and the provision of support to the Board of NUAA.

Many of NUAA's workers are people who do or have a history of using illicit drugs and of drug treatment — one of the biggest differences between NUAA and other services and organisations in NSW. Because NUAA's membership is mostly made up of people who use drugs and who are or have been engaged in drug treatment, we are uniquely placed to help improve the health, dignity and well-being of our constituents across NSW.

On behalf of us all at NUAA I pledge again to you that we will continue to work hard to deliver only the best possible programs and to fight to make the lives of people who use drugs illicitly in NSW better. With a strong, committed team we are well positioned to see some change in the next year. I hope that we have served you well.

Community Programs and Services Team

This is a busy team, working across the state building and sustaining relationships within peer networks, providing education and training and support as well as providing NSP both from our office in Surry Hills and through outreach programs. In addition this team is championing peer support in hepatitis C treatment.



The aim of PeerLink is to recruit, train and sustain groups of people who inject to act as Volunteer Peer Educators and work within local networks and with local services. Our improved model generated many outcomes.

Highlights of PeerLink this year include:

- Over 28 people have been involved across Toronto, Nowra and Mt Druitt
- A total of 9,516 peer education interventions were undertaken across the three sites
- A total of 7836 education resources were handed out across the three sites
- Sixteen update trainings were delivered across the three sites all with above 80% of the PeerLinkers in attendance
- Each site participated in World AIDS Day, International Drug Users Day and Hepatitis Awareness Week
- Mt. Druitt PeerLink concluded after three successful years of partnership with local services and the community.











This past year, NUAA's Peer Participation Program (PPP) has grown we have sustained a strong and vibrant team of up to twelve active participants. PPPs have participated across NUAA programs:

- NUAA events
- Representation

The PPP demonstrates the value of community controlled community development programs and how by empowering our community we make huge differences.



ENHANCED TREATMENT FOR HEPATITIS C IN OPIOID SUBSTITUTION SETTINGS (ETHOS)

NUAA concluded this year During 2013/2014 we continued to deliver our peer support services at four clinics as well as develop two very important tools that support community controlled peer support; Liver Mate – a great DIY kit for anyone wanting to start their own support group and a kit and tools to assist clinics and health services employ peer support workers.

Our Peer support services and tools are setting new precedents in community controlled peer support.









NUAA has been an active member in the development of LiverLife a Healthy Liver Campaign designed to bring awareness to liver testing and treatment and to help educate people about their liver. The initial phases of this study focus on developing and testing of the campaign messages and resources, which are designed to encourage people to maintain a healthy liver.

In total there were over 7,081 visits to NUAA's NSP an increase on the previous year.


Health promotion events included:

- NAIDOC week
- Hepatitis Awareness Week 114 people engaged in a special afternoon tea event.
- Overdose Awareness 648 people engaged in activities and 61 specific brief interventions were undertaken relating to overdose.



- RU OK Day on the day 21 people engaged in discussions and referrals having been asked RU OK?
- Mental Health 148 specific occasions of service relating to mental health across the week
- International Drug Users Day 35 specific engagements during the day regarding International Drug Users Day with an additional 18 people being referred to NUAA's programs and 9 staying to watch Rampant.
- No Partical vember! filtering 13 wheel filter demonstrations were held in the NSP.
- World AIDS Day Our NSP went RED! 129 resources were distributed during the day.
- Surviving Christmas
- National Condom day 147 condoms were distributed with 10 targeted health promotion activities were undertaken.
- Mardi Gras/ Safer Partying 88 targeted party packs were distributed.
- Promoting our Extended Distribution Pilot seven people attended an insitu session on the pilot project
- Steroid and performance enhancing drugs in situ peer run session was held and 8 people attended
- Work Development Orders (WDOs) guest speaker from Legal Aid engaged 10 people in a discussion and five were referred in to the program.

Scaling up our NSP coverage is important. We manage to continue to deliver a once a week outreach service to the Cabramatta area to 25 people.





Policy, Advocacy and Communications Team



Users News has continued to be a well loved and regarded part of the NUAA landscape this year. Four editions were published with a print run of 18,000 each.

We continue to review and update our distribution strategies ensuring that our stock is depleted and more people are able to get hold of a copy of the magazine.

Writing workshops were delivered in various settings across NSW.


Our Users News survey received 81 completed surveys – highlights include:

- Over 3/4s of readers had internet access
- 50% of readers have been reading for 1- 5 years
- The majority of readers pick up their copies or have it posted with friend, prison, prison officer and website being main sources.
- Copies are read on average by 3 people giving us a readership of 72,000 per edition

















WEBSITE

NUAA's website continues to be popular over the past year. Highlights include:

- There were 21,938 users over 25,807 sessions
- 84% were new sessions while 16% were returning visitors
- There were 500,582 page views.







TWITTER

NUAA remains engaged with our Twitter followers, highlights include:

- 321 tweets were made over 27 weeks
- NUAA was retweeted 98 times and favourited 50 times
- We entered into 23 conversations and received 62 mentions
- At June 30th 2014 we had 168 followers

Published quarterly the Newsflash continues to help us to keep all our members, stakeholders and allies up to date on our funded programs.

RESEARCH PARTNERSHIPS

This year we have worked in partnership with the now named Centre for Social Research in Health and the Kirby Institute on various research projects. NUAA was also invited to participate in three studies with the National Drug and Alcohol Research Centre.











Policy and Advocacy

This has been an exciting year for NUAA's Policy and Advocacy program. Highlights include:

- Implementing the pilot for extended distribution across NUAA's NSP services. This pilot sees
 people who access NUAA's NSP being authorised by the Director General to be able to
 legally give other people sterile fits. The pilot is being evaluated by the Centre for Social
 Research in Health and will run to June 2015. We hope that the pilot will enable the
 authorization to be extended to everyone accessing equipment from the NSW NSP.
- A successful event was held to launch our policy resource Stories from the Other Side, An Exploration of Injecting Drug Use in NSW Prisons. The event can be viewed here: https://www.youtube.com/watch?v=YYvf-aGE7HY
- Two position papers were distributed:
 - Hepatitis B vaccination for people who inject drugs
 - Performance and Image Enhancing Drugs and the NSW NSP
- We also launched our discussion paper on what we hope the NSW NSP will look like in 2020
- We held three policy symposiums:
 - o A community event to look at the impact of policy on the lives of our community
 - A community event to explore how to get involved in policy at the individual level
 - A forum to explore the NSW Needle and Syringe Program ad launch our NSP 2020 discussion document



Utilising the excellent resources form the Australian Injecting and Illicit Drug Users league, NUAA continued our much needed stigma and discrimination training program. Highlights include:

- Delivering the training to 308 people:
 - Six sessions with young people reaching 64 participants using the Max Marshall video and training tools
 - o Five session with our community reaching 28 participants
 - o Fifteen sessions with health care professionals reaching 308 participants
- Evaluation tells us that:



- o The majority of participants are finding the session very useful/useful
- The most useful component of the training is understanding the impact of stigma and discrimination as barriers to health care settings and understanding self-stigma, lateral violence and micro aggressions.
- The workshops are meeting expectations each and every time

RECONCILIATION ACTION PLAN


